Adamson says the ambiguous concept of "elite" may be the expression of superior academic achievement, high intelligence, learning super fast, there is an extraordinary talent or special ability, or a combination of all these. Havighurst Make It defines:"elite" or "talent" to someone who is one of the values of their ability and show considerable prominence. Education Commission of America to be considered elite in 1969:

- 1) talent of General Intelligence;
- 2) talents of special education;
- 3) creative thinking;
- 4) leadership ability;
- 5) artistic talents;
- 6) psychomotor ability.

Thus, "elite and excellence" is one who is recognized as the experts in each of the above areas or potentially has notable successes. These people make up approximately three to five percent of the school population. Have above-average IQs, special prominence of learning, the ability to think abstractly, to provide answers to complex and new, quick understanding of relationships between elements, the ability to generalize, extent and diversity of vocabulary, strong memory, high energy, the power of imagination, high concentration, the curiosity, passion and strong incentive, good temple, speech very well, humor, interested in big things leadership ability is The most popular features in the Elite persons.

B) enrichment of content:

The "content enrichment" enriches and enhances the regular classroom curriculum. The purpose can be achieved by adding a variety of educational activities and tasks the. Curriculums Sometimes can add enrichment of content by providing more details or examples and instances of the wealth. In this way, an opportunity is created for the elite, according to their needs and abilities have deeper and broader understanding of the subject and develop their intellectual skills and talents.

C) complex content:

In this method, the terms, concepts and principles in the preparation of the content is used for the middle class are not able to understand them thus elite student confronts with subjective challenges, To understand it, to refer to previous knowledge and taking advantage of them to reach the idea further. Content and complex topics elite learners to abstract concepts and theirs can be generalized to different cases.

2) change the Educational methods

Teaching method is one of the important pillars of the education process. After learning objectives were defined and characteristics and abilities of students were surveyed, teaching method is chosen and in the classes is conducted. The teacher or professor teaches to befit the course objectives and learning readiness and capacity. In addition, the level of education can divide in the "Understanding" (understanding concepts), "applying" (to get ideas in the various situations), "analysis" (content or subject of analysis and its components), "combinations" (putting together the elements and to reach a whole new idea) and "evaluation" (measure and judge the contents and subjects). If the aim of education is the only way to transfer knowledge and information to the students, "speech" is appropriate. But if this level is not sufficient, based on the needs and talents learners, should be considered higher objectives, the method of "discovery" to which they are applied, the learner will actively explore and construct of knowledge. In this space, training facilities and instructors who are featured, elite persons have communicated and interact with others and in growth and development, are competing with each other.
